

As construction continues on the I-10 Express Lanes project, work in the City of Ontario will generally occur Monday through Friday during daytime (6:00 a.m. to 4:00 p.m.) and nighttime (9:00 p.m. to 5:00 a.m.) hours, except as noted below. Please remember, all construction is dynamic and the schedule is subject to change.

ALERTS!

- **55-Hour Freeway Lanes and Ramps Closures:** Crews will be realigning and paving the freeway for 55-hours and there will be lane, ramp, and connector closures (detour routes will be posted):
 - TONIGHT! Friday, November 12 at 10:00 p.m. through Monday, November 15 at 5:00 a.m.
 - Eastbound (EB) I-10 three lanes closed from Milliken Avenue to the I-15
 - EB Milliken Avenue on-ramp and the EB I-10 to northbound (NB) I-15 connector will also be closed.
 - Scheduled Friday, November 19 at 10:00 p.m. through Monday, November 22 at 5:00 a.m.
 - EB I-10 three lanes closed from Milliken Avenue to the I-15
 - EB Milliken Avenue on-ramp and the EB I-10 to southbound (SB) I-15 connector closed also closed.

Bridge Demolition and Construction

Eighteen bridges throughout the corridor are being replaced, widened, or improved to accommodate the widening of the freeway. During times of demolition, shoring, and backfilling, work will be loud and vibration will occur. You will see bright lights and hear equipment including excavators, backhoes, loaders, and dump trucks. Bridge activities in Ontario include:

- **Benson Avenue:** A portion of the EB I-10 shoulder over Benson Avenue was removed in early December 2020. Bridge widening work will continue for approximately two years. Benson Avenue is reduced to one lane in each direction.
- **Mountain Avenue:** In November 2020, crews removed a portion of the EB I-10 shoulder over Mountain Avenue. Bridge widening work will take approximately 18 months. Daytime activities include building portions of the bridge deck and cap.
- **San Antonio Avenue:** Crews are continuing to relocate utilities on San Antonio Avenue and preparing the bridge for demolition, anticipated in late-2021.
- **Euclid Avenue:** Crews demolished the east side of the bridge and are working on rebuilding the NB lanes. Work on Euclid Avenue began in mid-May 2020 and will last for approximately 18 months. Daytime and nighttime activities include installing and relocating utilities.
- **Sultana Avenue:** The Sultana Avenue bridge over I-10 is now open.
- **Campus Avenue:** Campus Avenue over I-10 was demolished in mid-October 2021. The bridge will be rebuilt into a wider configuration to accommodate the additional lanes on the I-10. Construction will last approximately nine months. Nighttime activity includes installing steel plates into the ground (shoring).

- **6th Street:** 6th Street over I-10 was demolished in early October-2021. The bridge will be rebuilt into a wider configuration to accommodate the additional lanes on the I-10. Construction will last approximately nine months. Daytime activities include earthwork, excavation and installing abutment tiebacks.
- **Grove Avenue:** A portion of the EB and westbound (WB) I-10 shoulder over Grove Avenue was removed in December 2020. In December, steel beams (girders) will be installed next to the EB shoulder. Daytime activities include constructing bridge walls and footings.
- **4th Street:** Crews continue to relocate underground utilities at 4th Street and are building a new wider section of the EB side of the freeway. Work on 4th Street began in spring 2020 and will last for approximately two years. 4th Street between El Dorado Avenue and Vineyard Avenue is reduced to one lane during daytime hours. 4th Street under I-10 will be closed nightly from 7:00 p.m. to 5:00 a.m. Detour routes will be posted. Daytime activities include forming the bridge deck and diaphragms.
- **Vineyard Avenue:** The east side of Vineyard Avenue over I-10 was partially demolished in early March 2021. Construction will last approximately 18 months. Vineyard Avenue over I-10 may have reduced lanes during daytime and nighttime hours. Daytime activity includes building the bridge walls.
- **Cucamonga Wash Bridge:** The EB I-10 over the Cucamonga Wash Bridge is being widened. Construction will last approximately nine months. Daytime activities include building the abutments and footings.
- **Day Canyon Channel:** Work began in early August 2021 to widen the I-10 over Day Canyon Creek. Construction will continue for approximately nine months.

Retaining and Sound Wall Work:

Crews will continue to demolish and rebuild retaining walls and sound walls at several locations near the EB lanes of I-10 between Mountain Avenue and San Antonio Avenue and intermittently between 6th Street and Vineyard Avenue. This work will be loud and vibration will occur. Equipment used includes excavators, backhoes, loaders, dump trucks, and concrete mixing trucks.

Retaining walls and sound walls are located on State property next to the freeway. K-rail is placed on the freeway shoulders and crews work between the k-rail and wall locations. Once walls are demolished, materials are removed so crews can prepare the land for the replacement wall.

Daytime Retaining and Sound Wall Activity: Work will occur Monday through Friday between 6:30 a.m. and 4:00 p.m. Streets adjacent to this work includes:

Local Street Closures:

Crews are removing sound walls and retaining walls, relocating utilities, and removing trees on several local streets adjacent to the I-10; at times this work may be loud and you may feel vibration. One side of the sidewalk will always remain open.

- Daytime and/or nighttime lane closures, streets will remain open:
 - Benson Avenue, Mountain Avenue, San Antonio Avenue, Euclid Avenue, Grove Avenue, 4th Street, Fresno Avenue, Princeton Avenue, and Vineyard Avenue
- Nighttime street closures, detour routes will be posted:
 - Princeton Avenue: EB/WB intermittently closed approaching Grove Avenue
 - 4th Street: EB/WB street closed under I-10 from 7:00 p.m. to 5:00 a.m.

Ramp Closures:

- EB Milliken Avenue on-ramp and the EB I-10 to NB I-15 connector are scheduled to close Friday, November 12 at 10:00 p.m. through Monday, November 15 at 5:00 a.m. Detour routes will be posted
- EB Milliken Avenue on-ramp and the EB I-10 to SB I-15 connector are scheduled to close Friday November 19 at 10:00 p.m. through Monday, November 22 at 5:00 a.m. Detour routes will be posted
